- Cycling section has no young members and BMX could draw young members to cycling
- Good to share clubrooms and grow member numbers
- Suggestion of special general meeting to be held for club members
- ACM may not have exclusive use of clubrooms once lease expires
- Discussion needed at club level due to insufficient consultation
- Summary of BMX club's work and intentions to be distributed to harrier and cycling sections.
- David F Proposes that in 2 months time a decision is to be voted on Wednesday 21<sup>st</sup> August. Check constitution for proxy votes.
